BlueWave, Connect the Business on the Clouds

Project Description

BlueWave (picture 1) is a platform for management of complex transactions¹ between Business Partners (B2B, Business-to-Business) in a 'Cloud' environment. It was firstly developed as a concept for broadband services in 2008 for the (that time) Third UK Broadband Operator and was further extended in 2011 (with a private investmen) to be positioned in the new sector of the "**Cloud Services Brokerage**".

The Company has won the Telecom Italia 2011 "Working Capital" award (price of the United Kingdom Minister of Trade and Investment (UKTI) "UKTI Entrepreneurship Award") and has positioned in 2011 research and development activities in Italy with a start-up company in Milano.

The platform features the following capabilities:

- SOA (Service Oriented Architecture) Design supporting integration of Cloud Services with IT Management capabilities positioned in different 'vertical' sectors (e.g. Telecom, Energy, On-line services)
- Enablement of "IT BSS" (Business Support Systems) capabilities such as: Customer Management (Business, Multi-hierarchy and Consumer accounts), management of a Product/Service Catalogue, management of business Orders and Transactions on such catalogue, modeling of related Business Processes (BPM) (JBPM, Drools), management of the connected Costs and Invoicing, management of Payments, management of Technical Assistance, brokerage of external Events, support for Reporting
- On-line (web based) Administration and support for the integration with a Customer Management component (Portal)
- High attention to Security and Performance, with the use of "Open Source" 'best-

of-breed' components (JBoss, Drools, Tomcat, Postgres, MySQL, Java Enterprise)

- Support for SAAS and "Cloud" deployment models, both on traditional HW architectures and "On-the-clouds" (e.g. Amazon EC2, Cloud Telecom Italia)
- Scalable and multi-tier architectures (e.g. traditional "3-tiers" or distributed on Enterprise Bus)
- Support of market integration standards (e.g. web-services, JMS, XML, Event Mediation)
- Full coverage of BSS (Business Support System) "horizontal" functions with flexibility to adapt to different "Vertical" market segments (e.g. Telecom, Energy, M2M)

The **reference Customer** for the platform is a Business Entity that needs to enable business transactions (simple or complex) with one (or multiple) Business Partner in a Cloud or B2B Brokerage environment on the bases of a complex Services Catalogue. The high level reference architecture is as for the following picture:

Current project state

The platform has been developed in 2011 to reach a "PRE-production" software release in **September 2011** in an Amazon EC2 environment.

From July 2011 several Customer Prospects has been selected (initially in UK and Italy) for a commercial proposal and/or implementation of "ad-hoc" PoCs (Proof of Concept) based on specific customer requirements.

4 potential customers (Telecom, Energy, M2M Modem Manufacturer, Software Vendor) have been selected and proposals of Trials have been done.

On the bases of the collected customer requirements some PoCs will be implemented as an anticipation of a possible sectorial product (e.g. integration of a CSP with a Cloud Partner, Gas Meter Reading, Remote M2M MODEMs Management).
